

Application for renewal to the Code of Practice, Treatment Abroad

2.5	<b>Payment information</b>	Details of how to pay including when deposits are payable is clearly explained on the FAQ section of the website. 2.9	<b>Patient Journey</b>	The patient journey explains arranging the first consultation, booking treatments; travel and accommodation. 2.12	<b>Patient Information</b>	A range of information sources were provided to support this standard. Post-Operative Instructions following Placement of Dental Implants, Surgical Extraction and Sinus-Lift was reviewed by the assessor, meeting the expectations of the Code of Practice. The post whitening care instructions also supported this standard. In the opinion of the assessor the information was clearly presented.	<b>Met</b>
