An innovative ophthalmic surgeon, he is responsible for the introduction of a streamlined state-of-the-art cataract service that allows both private and NHS patients to access pre-operative assessment and surgery on the same day.

Committed to staying fully abreast of the latest developments in his field, Mr Alwitary is in the final year of his MSc in Cataract and Refractive Surgery. A regular contributor to the medical literature, he has published more than 35 peer reviewed articles, authored two medical text books and is the editor of a leading text for ophthalmic trainees.
